4 **ELECTRONIC FILING IS REQUIRED and EXHIBITS MUST BE PRE-SUBMITTED**

5 Given the number of potential participants, to avoid requiring the participants to
6 bear the expense and complexity of providing service for all pleadings and other filings,
7 electronic filing will be required. All exhibits must be submitted to the Office of
8 Administrative Hearings ("OAH") by electronic filing prior to the hearing. Shortly after filing,
9 an electronic copy of each document or exhibit filed will be posted at
10 <http://www.azoah.com/Water.htm>. To ensure that the Applicant, ADWR and other
11 Interested Persons have adequate access to these files, all electronic filings should be
12 set to limit page sizes to 8 ½ x 11; files that are not so configured will be rejected.

13 Electronic filing will constitute valid service and no service to the Applicant, ADWR
14 or other Interested Persons will be required. See A.R.S. § 41-1091.04; Arizona
15 Administrative Code R2-19-102. To access these filings the Applicant, ADWR, and

- 26 4. February 12, 2007 -- Applicant's Response to ADWR's Pre-Hearing Brief and
27 Position, and Applicant's Response to other Interested Persons' Pre-Hearing Briefs and
28 Positions (no replies will be considered);
- 29 5. February 12, 2007 -- ADWR's Proposed Witness List (including a fair statement
30 of the proposed testimony and estimate of time required) and List of Exhibits;
6. February 14, 2007 -- Filing of Applicant's and ADWR's Exhibits;

7. February 15, 2007 -- Deadline for all motions, written comments (testimony) and requests for time for interested persons to testify orally. Such requests must include a brief summary of the proposed testimony and a statement as to why oral testimony is required and written testimony is not sufficient;

8. February 22, 2007 -- Responses to Outstanding Motions (no replies will be considered);

To help ensure efficient use of time at the hearing, on or before February 26, 2007 the assigned Administrative Law Judge will post a schedule for oral testimony;
